THE SECOND SCHEDULE above referred to

- 2. No buildings other than private dwellinghouses with necessary outbuildings are to be erected on any part of hereditaments hereby assured Provided that this restriction shall not apply to ordinary farm buildings erected on any part of said hereditaments while the same shall continue to be used for the purpose of agriculture.
- 3. Except as mentioned in Stipulation Number 2 only detached dwellinghouses occupying a site of not less than half an acre are to be erected the cost of which is to be not less than £800 each exclusive of the cost of laying out the land the cost of drainage and the cost of erecting outbuildings.
- 4. No part of the said hereditaments hereby assured or any building thereon shall at any time be used for any trade manufacture or business except that of agriculture.

NOTE: The points marked E and F referred to above do not affect the land in this title.
